

INFORMATION CLAUSE - CONFERENCE PARTICIPANTS

Pursuant to Art. 13 sec. 1 and 2 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (i.e. General Regulation on data protection) (Journal of Laws UE.L 2016 No. 119, p. 1), hereinafter referred to as the GDPR, we inform that:

1. The administrator of your personal data is Politechnika Rzeszowska im. Ignacy Łukasiewicza with its seat at al. Powstancow Warszawy 12, 35-959 Rzeszow, phone no. +48 17 865 11 00, e-mail address: kancelaria@prz.edu.pl.
2. The administrator has appointed a Data Protection Officer supervising the correctness of personal data processing, who can be contacted by calling +48 17 865 1775 or by writing to the following e-mail address: iod@prz.edu.pl or to the address of the Administrator's office, in any case regarding the processing of your personal data and the exercise of rights related to the processing of such data.
3. Your personal data will be processed for the purpose of:
 - a) organization and conduct of the Conference, including registration of participation, communication with participants on organizational matters, documenting the course of the Conference, as well as issuing post-conference materials - pursuant to Art. 6 sec. 1 lit. e GDPR, in connection with the implementation of the tasks and mission of the university in the field of education, scientific activity, as well as participation in social development and the creation of an economy based on innovation;
 - b) conducting video monitoring in the University's facilities, which is the legitimate interest of the Administrator - pursuant to art. 6 sec. 1 lit. f GDPR.
4. In the case of people participating in the Conference in a stationary mode and people participating in the Conference in a remote mode (on-line) with a webcam turned on, your personal data (image) will be processed on the basis of art. 6 sec. 1 lit. a, i.e. by expressing consent in the form of an unambiguous confirming action, which is understood as personal participation at the Conference venue or the inclusion of a webcam in the case of remote participation. Your image may be disseminated in connection with the live broadcast of the Conference on Internet TV, the Internet and on the YouTube channel, and it may also be recorded in the form of photos, videos and recordings and disseminated in connection with the Conference by publishing materials in the media, on the Conference website and on the Conference profiles in social networks.
5. Providing the data is voluntary, but necessary to achieve the purposes for which it was collected. Refusal to provide them is tantamount to the inability to register and thus not to participate in the Conference.
6. The recipients of your data (name, surname, affiliation, e-mail address) may be organizations managing and controlling the Projects "JANUS: e-Pedagogy and Virtual Reality Based Robotic Blended Education (Project No 2020-1-PL01-KA226-HE-095371) and PLANET4: Practical Learning of Artificial iNtelligence on the Edge for indusTry 4.0 (Project No 621639-EPP-1-2020-1-IT-EPPKA2-KA), as well as other external entities only in cases provided for by law.
7. Your personal data will not be transferred to a recipient in a third country or an international organization.

8. Your personal data will be processed until:
 - a) achieving the purpose of processing, or
 - b) revocation of the consent constituting the basis for this processing, or
 - c) objecting to data processing;and after this period, stored for the time and for the purpose and scope required by law.
After the expiry of the storage period, these data will be irreversibly anonymized.
9. The Administrator may entrust the processing of your personal data to external entities acting on behalf of the Administrator, e.g. an entity providing IT services in the field of development, servicing and removal of failures in IT systems.
10. You have the right to access your data, rectify it, delete it or limit its processing, and the right to object to its processing, as long as it is permitted by law.
11. Withdrawal of consent to the processing of your data (image) will result in irreversible anonymization before the expiry of the storage period, their removal and complete suspension of their processing. From the moment you receive the withdrawal of consent, your image will not be included in the media materials, with the exception of materials produced prior to the receipt of the withdrawal.
12. You have the right to lodge a complaint with the supervisory body (i.e. the President of the Personal Data Protection Office) if you believe that the Controller violates the provisions of the GDPR while processing your personal data.
13. Your personal data will not be subject to automated decision-making processes (including profiling).
